## NOTE FROM THE PRESIDENT

---

Dear Friend,

Thank you for the support rendered to the Junior League of Washington in our wildly successful 106 years of volunteer service. While developing the potential of more than 2,300 members, we advanced our meaningful mission and made significant strides towards our valiant vision by "Living Our Values Every day."

With the adoption of a Code of Conduct, each member agreed to honor community, leadership, service, diversity, collaboration, empowerment, respect, and integrity through deeds and words.

We lived the value of leadership by providing 181 women formal leadership opportunities, offering 43 women specialized leadership development, coordinating 37 educational sessions, and fostering governance experience for 18 women.

We lived the value of service by contributing more than 58,000 hours of service, producing an estimated annual value of more than \$2.25 million dollars. Our impact was recognized and resulted in the League's receipt of five awards for exceptional volunteer service.

We lived the value of diversity by creating a Diversity & Inclusion Toolkit, which included cultural competency primers, an equity calendar, and a database of members who are subject matter experts, capable of serving as internal or external resources. Further, by establishing Sisters in Service, a Sustainer Interest Group, we provided mentorship for underrepresented active members.

We lived the value of collaboration by establishing a Strategic Advisory Board to increase ways in which we connect and collaborate to the broader community. In addition, we strengthened internal operations from newly formed collaborations with DC Government, DC Bar Foundation, and Compass.



We lived the value of empowerment by introducing the 1912 Legacy Circle to ensure the purpose and power of the League continues for generations to come.

We lived the value of respect by advancing civility and by respecting our collective assets. By focusing on the protection of Loughborough House, we completed a property diagnostic report, replaced our roof, and adopted a three-year staffing plan for the personnel tasked with administering work within our headquarters.

We lived the value of integrity by allocating \$3,240 of dues scholarships to members with varying financial abilities, demonstrating our unwavering commitment to strong moral principles. 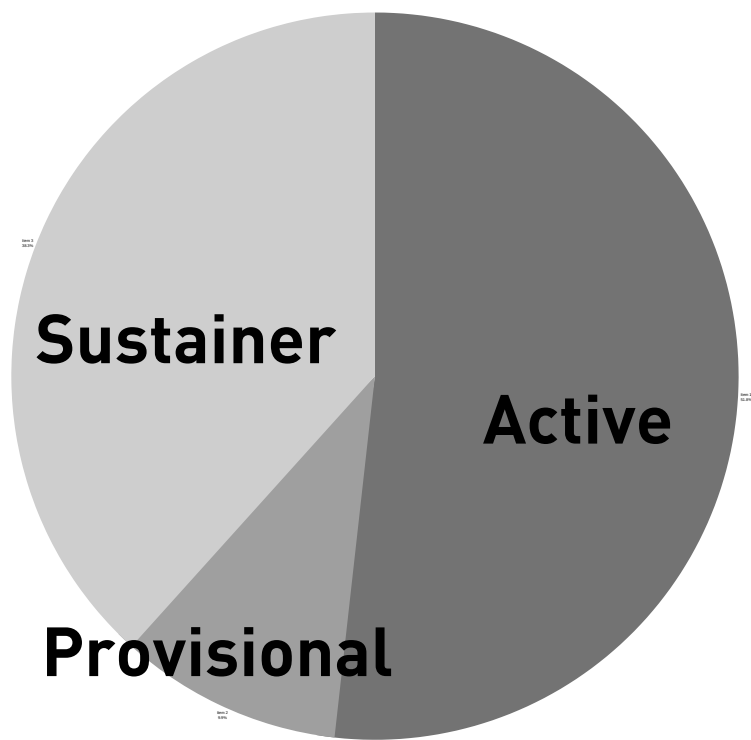

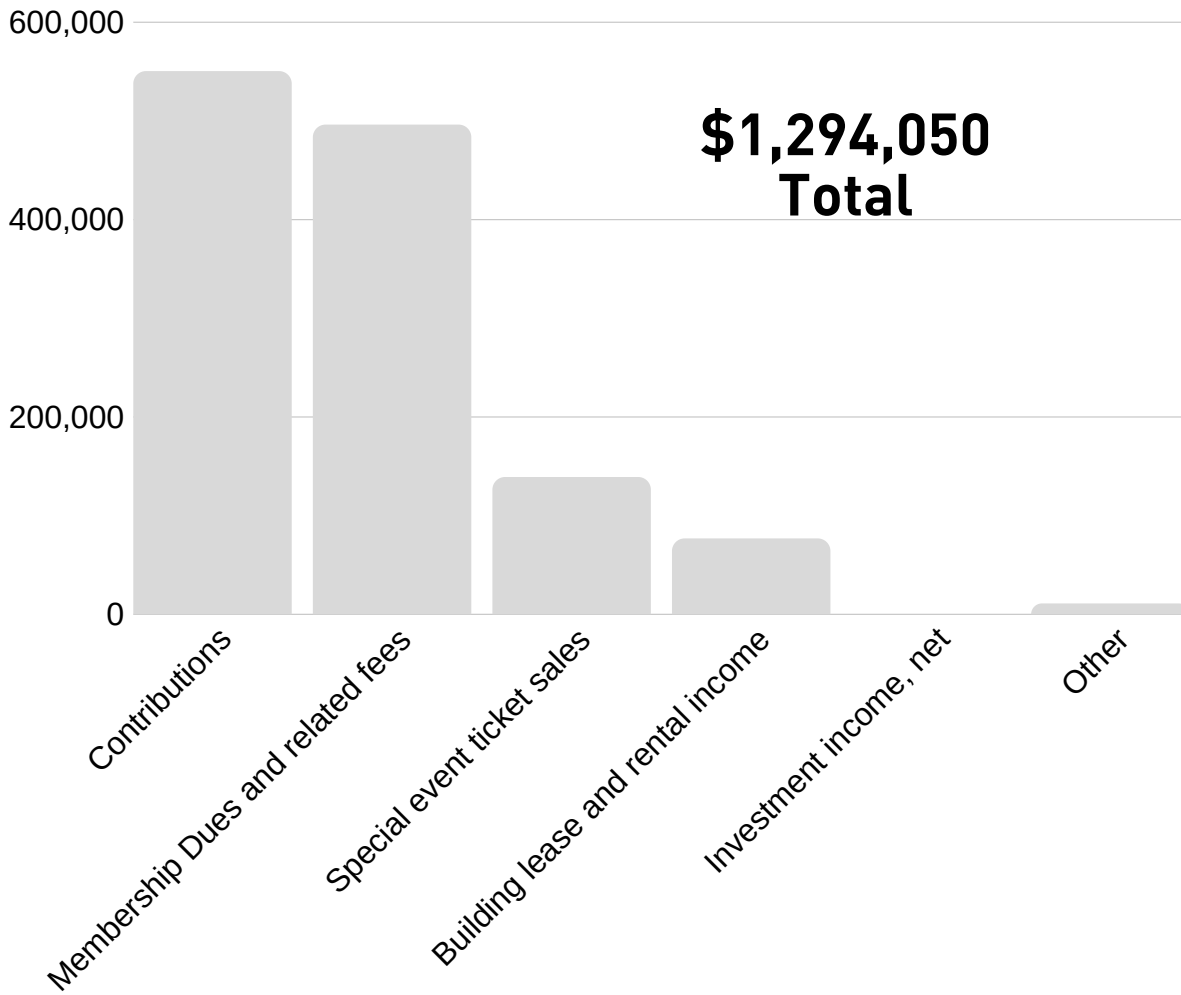

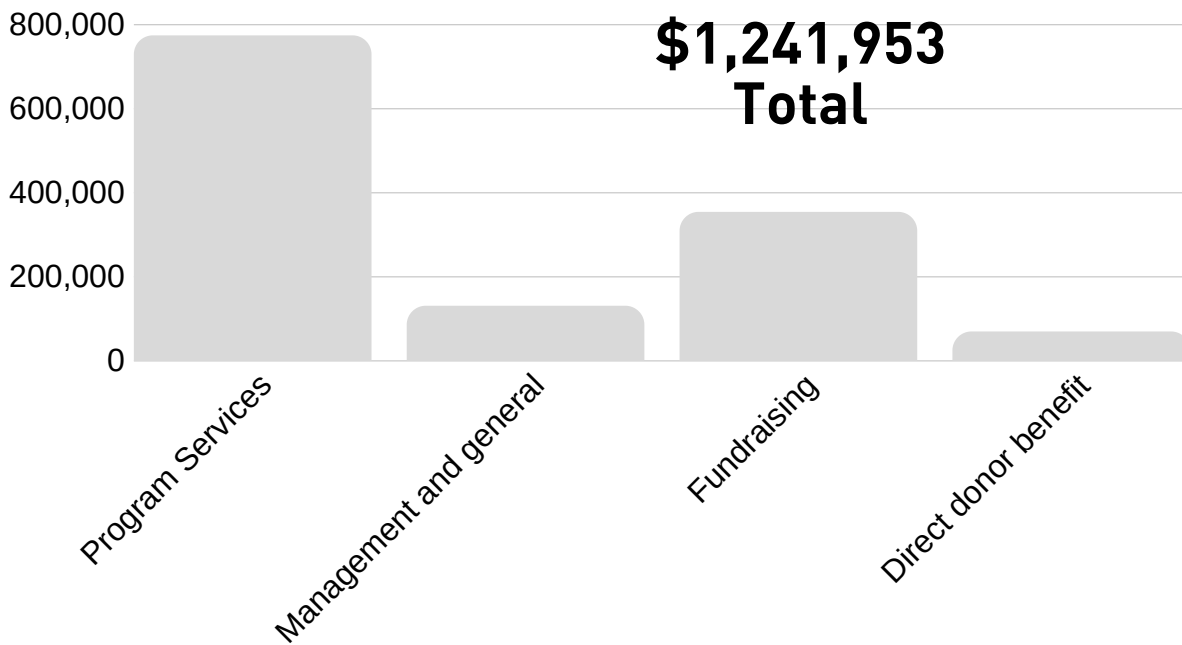
